DIRECTORS REPORT: Mr. Berry reported that the water loss percentage was not correct, he said that SW Boone isn't reading the meters on the 15th of each month and he will talk to SW Boone about the issue, it throws our water loss figures off.

WATER OPERATOR REPORT: Bobby reported still looking for leaks.

METER READER REPORT: Tom had no report other that to say thanks for allowing a leave for July and August and would be back in September. Bobby Hudson will be reading meters with John Berry Assistance.

BOOKKEEPER REPORT: Veronica submitted monthly reports for May 2011 Board Members and submitted them into the minutes. Motion was made by Wanda and second by John to accept them into minutes. Motion carried. Also reported was that Arkansas Natural Resources came for their final audit for 2010 and will submit a report to us sometime in July or August. It was recommended that we put in the budget \$2,000.00 for an annual audit and \$500.00 for IRS Tax Preparation. It was also reported that we are in a position to reduce Arkansas Natural Resources for 2010 past due amount. It was also recommended by Arkansas Natural Resources that the Bank Statement be brought to the meeting and one of the Directors look it over. Oitker also reported there were 18 people who were currently signed up on auto withdrawal.

2. John reported that 2 radios were given to CWA by another company that were changing out radios and getting new ones and gave us old ones.

3. Locks - John reported that locks were now purchased with new/different keys.

NEW BUSINESS:

FEMA: John reported that FEMA requirements were too late for us to take advantage of, we have already covered up the work and it's completed so he recommended that we abandon the attempt to collect from FEMA.

STORAGE UNIT: Oitker reported that Arkansas Natural Resources wanted us to get rid of the old documents and keep nothing in our possession prior to 5 years. John reported that we need to move forward at looking a building. A survey was discussed and it was also discussed to determine the property lines.

SW BOONE RATE INCREASE: John reported that SW Boone agreed to delay rate increase until August and we would have to absorb the increase and not pass it on to our customers.

MARK HILL LETTER: Mark Hill wrote a letter to CWA requesting to relocate his meter and remove Thompson meter which is located on his property; he said he would assist with labor and \$250.00 towards cost to relocate. It was decided we can't relocate his meter and the cost of this relocation should be upon Mr. Hill and not CWA.
